\* Sale income shall mean sale income from passenger carriage and activities related to passenger carriage.

**Entrance fee** shall be in the amount of annual membership fee; however, it cannot exceed 500, - euros.

---

**PAYMENT PROCEDURE OF ENTRANCE AND MEMBERSHIP FEES**

*(established by the General Meeting of Members on 20 Dec 2018)*

New members ***shall pay initial contributions within one month*** after the decision to admit to the Lithuanian Passenger Transport Association has been made.

A membership fee shall be paid ***until each 31<sup>st</sup> of January***.

The membership fee may be paid ***as a lump amount or in instalments***, depending on the total membership fee, i.e.:

- if the membership fee is smaller than 4000 euros, it shall be paid as a lump amount;
- if the membership fee is between 2500 and 4000 euros, it shall be paid in equal shares every half year until the end of the first month of each half year;
- if the membership fee is 4000 euros or more, it shall be paid in equal shares every quarter until the end of the first month of each quarter.

***The amount of membership fee shall be fixed*** according to the sale income of previous year indicated in the approved financial accountability (income from passenger carriage and activities related to passenger carriage). If the membership fee paid in the beginning of the year is smaller than fixed according to the data of the financial accountability of previous year, the member shall pay the

difference until the 31<sup>st</sup> of May. If the membership fee is bigger, the difference shall be included into future payments of the member.

***Income from passenger carriage and activities related to passenger carriage*** is received from the following activities:

- carriage of passengers on local (urban), suburban, long-distance, international routes and chartered carriages (including transport concessions and grants),
- income from activities of bus stations,
- shipments,
- rent of buses,
- advertising,
- sale of buses.

### **PAYMENT PROCEDURE OF THE FIRST MEMBERSHIP FEE OF NEW MEMBERS**

*(established by Presidium's Members on 15 Jan 2019)*

New members ***shall pay the entrance fee and the first membership fee within one month*** after the respective decision has been made.

The membership fee for new members is calculated in proportion to the time remaining until the end of the year, starting from the next month after membership begins.
